

The ASHM Nominating Committee presents the following candidates for three year terms on the Board of Governors, beginning September 2014.

To serve a 1st term

Rikard ("Rik") Edstrom is a Vice President in Brown Brothers Harriman & Co.'s Not-for-Profit Practice where he delivers lending and investment management solutions to private schools, cultural institutions, land trusts, professional societies and other 501(c)3 organizations. Mr. Edstrom joined BBH in 2003 as an Associate in the Middle Market Corporate Banking group. Prior to joining BBH, he was a Venture Analyst in the Technology & Life Sciences division of Comerica Bank focusing on early through late-stage technology companies. Mr. Edstrom has a Bachelor's degree in Marketing from Schiller International University / American College of Switzerland and an M.B.A. in Finance from Drexel University. Mr. Edstrom is a past board member and Treasurer of the Swedish American Chamber of Commerce – Philadelphia. Born and raised in Stockholm, Sweden, Mr. Edstrom has attendedcolleges and universities in Europe (Germany and Switzerland) and the United States, and traveled extensively throughout the world. Mr. Edstrom has resided in Center City Philadelphia for the past 16 years, where he met his wife Lea. His personal interests include traveling, digital photography, sailing, scuba diving, and practicing and teaching freediving (certified PFI freediving instructor, founder and owner of Philadelphia/Miami based Revolution Freediving).

Sigrid E.
